Good Bears of the World (“GBW”) is pleased to be presenting The Bill Boyd Memorial 2010 Teddy Bear Jubilee. This will be the 20th Teddy Bear Jubilee, and will be filled with **“Treasured Memories.....Jubilees Past Present & Future”**, our theme for this year. Bill Boyd originated this show as a fundraiser for Good Bears of the World in 1990, and we are continuing his traditions in our fourth year of producing the show. We hope you will remember all the fun we have had at past conventions and shows, and that you will want to be a part as we continue old traditions, and start new ones at this year’s event!

The Teddy Bear Jubilee will be held again at the KCI Expo Center, which is located in Kansas City, MO, north of the river, and very close to the Kansas City International Airport. This location is very convenient for all the artists and collectors that are traveling in from other cities, especially those who are flying. Due to a scheduling conflict and our desire to keep the show at the same great location, we have moved the dates of the Jubilee to **September 23rd through 25th**. We plan to hold future shows on the last weekend of September.

We are offering a **Collector Package**, which includes the Friday night Banquet (including a chance to win the centerpiece), admission to the Friday night Auction, Souvenir Bear, Souvenir Pin, Program, and Early Admission to the Show on Saturday. This year we are adding a Friday night *Artist Preview*, and will be opening the showroom for a sneak peek before the Banquet! Optional, we will be having a special trip to the Kansas City Toy and Miniature Museum, where a special exhibit of memorabilia from past Jubilees and this year’s Auction Pieces, will be on display. The price of the Collector Package is \$145. **We are also offering an Early Pay Discount. If your Collector Package is paid in full by June 1st, you may deduct \$5.**

This year’s **Souvenir Bear** is being made by Once Upon a Needle, a collaboration by Peggy Fleming, Joel Hoy and Terri Larson. The Souvenir Bear will be related to our theme, and we know you will want to add one to your collection.

If you do not want to sign up for the full Collector Package, you may purchase the banquet separately at \$50 each. The banquet requires pre-registration and will also include admission to the artist preview and auction. You can also purchase show admission at the door on Saturday for \$6 adults and \$1 for under 12. (No strollers please!) Early bird admission to the show is only available with the Collector Package. Souvenir bears (subject to availability, expected to be very limited) may be purchased separately for \$130. Tickets for the trip to our exhibition at the Kansas City Toy and Miniature Museum, are a separate purchase.

Rooms at the Holiday Inn – Expo Center are available at a special rate of \$99. In order to receive this rate, reservations must be made through GBW or through a special link that will be provided to you. **Reservations must be made by August 15th** to ensure the group rate. Guest charges are payable directly to the hotel at checkout. The Holiday Inn – Expo Center was opened late October 2006, and we have received lots of positive feedback regarding this hotel

from exhibitors and collectors alike. It is connected to the KCI Expo Center via a covered walkway, and is the most convenient hotel to the exhibition area. There are also other hotel options in the area, if you choose.

The hotel offers **free shuttle** service from the Kansas City International Airport to the hotel.

Lunch arrangements for Saturday will be provided at a later date. We expect the Café at the Expo Center will be open again this year.
