Good Bears of the World (“GBW”) is pleased to be presenting **The Bill Boyd Memorial 2011 Teddy Bear Jubilee**. This will be the 21st Teddy Bear Jubilee, and will be celebrating “**The Magic of Teddy Bears**”, our theme for this year. Bill Boyd originated this show as a fundraiser for Good Bears of the World in 1990, and we are continuing his traditions in our fifth year of producing the show. We hope you will be a part of this exciting event as we continue Jubilee traditions.

The Teddy Bear Jubilee will be held again at the KCI Expo Center, 11730 N. Ambassador Drive, Kansas City, MO 64153. The Expo Center is located in Kansas City, MO, north of the river, and very close to the Kansas City International Airport. This location is very convenient for all the artists and collectors that are traveling in from other cities, especially those who are flying. This event will be held **September 22nd through 24th**. We plan to hold future events on the last weekend of September.

We are offering a **Collector Package**, which includes the Friday night Banquet (including a chance to win the centerpiece), admission to the Friday night Auction, Souvenir Bear, Souvenir Pin, Directory, and Early Admission to the Show on Saturday. After a huge success last year, we will again host an **Artist Preview** from 5 pm to 6 pm on Friday night for a sneak peak at the Show Room. This Artist Preview is for Registered conventioners **ONLY**. **We are also offering an Early Pay Discount. If your Collector Package is paid in full by June 1st, you may deduct \$5.**

This year’s **Souvenir Bear** will be created by Martha Burch of Martha’s Bears. The Souvenir Bear will relate to our theme, and we know you will want to add one to your collection.

If you do not want to sign up for the full Collector Package, you may purchase the banquet separately at \$50 each. The banquet requires pre-registration and will also include admission to the Artist Preview and auction. You can also purchase show admission at the door on Saturday for \$6 adults and \$1 for under 12. (No strollers please!) Early bird admission to the show is only available with the Collector Package. Souvenir bears (subject to availability, expected to be very limited) may be purchased separately for \$130.

Rooms at the Holiday Inn – Expo Center are available at a special rate of \$99. In order to receive this rate, reservations must be made through GBW. **Reservations must be made by August 15th** to ensure the group rate. Guest charges are payable directly to the hotel at checkout. The hotel is connected to the KCI Expo Center via a covered walkway, and is the most convenient hotel. The hotel offers **free shuttle** service from the Kansas City International Airport to the hotel. There are also other hotel options in the area, if you choose.

Lunch arrangements for Saturday will be provided at a later date. We expect the Café at the Expo Center will be open again this year.

Our Friday activities will be two workshops. The first one is *Seasonal Decoration with Teddy Bears and Antiques*, and will be presented by Peggy Fleming, Joel Hoy and Terri Larson of Once Upon a Needle. The second workshop will be by Ken Yenke titled "*The True History of the Teddy Bear*" and a presentation by Brenda Yenke on cleaning old bears. Ken will also be available for bear appraisals at the Saturday show.

We will be holding the **Good Bears of the World Charity Auction** on Friday evening after the banquet. This Charity Auction has always proven to lots of fun. We will be posting auction pieces on our website www.teddybearjubilee.com prior to the show. We will be accepting absentee bids on the auction items.
